All Sales Final. No Refunds, Cancellations or Exchanges

Half of the total McKinney Roe Vikings VIP membership fee is due upon joining. The remaining half is due 30 days prior to the first game of the pre-season. Payments must be timely made on or before the dates listed in any agreed upon payment plan. Delivery of tickets shall be made no later than seven days prior to the first game of the pre-season, and only upon receipt of full payment or for accounts that have not fallen behind in payments. For those on installment payment plans, in the event you fail to make any timely required payments, your membership will terminate, and any payments you made prior to the termination date will be forfeited by you. Notwithstanding the termination of your membership, you remain liable for the full payment of your purchase price.

Membership payments are non-refundable and must be applied to a full year membership.

Renewal Procedures

Membership renewal notices will be delivered to the member of record for each account.
